9. Burning Season opens 1/15/2024
Burning Permit Regulations

Open burning is prohibited in the following areas: Minot, Humarock and any location EAST of Hatherly RD.

The Scituate Fire Department will strictly enforce the following State regulations. All permit holders must agree to abide by these rules, with the understanding that the Scituate Fire Department reserves the right to refuse or revoke any permit that does not conform to these rules.

- a. The open burning season for residential properties will be from January 15, 2024, through May 1, 2024
 - b. Permit burning is only allowed between the daylight hours of 10:00am to 4:00pm and all fires must be started before noon and all fires must be completely extinguished by 4:00 pm
 - c. Burning sites will be spot checked and permits for areas not meeting these requirements will be refused or revoked
 - d. All fires must be at least 75 ft from any structure and you must have an available water supply, such as, a pressurized water pump, can, or hose and shovels or rakes for controlling the fire.
 - e. **ONLY BRUSH MAY BE BURNED: LEAVES AND GRASS MAY NOT.** All fires must be tended to at all times. Piles of brush must be kept small and manageable. If fire extends beyond the initial area the permit may be revoked.
 - f. If we receive a complaint that the fire is causing a smoke nuisance, the fire will have to be extinguished.
 - g. You must check online each day to verify and request burning.
- Permission will be granted only on those days when winds, dryness of woods and atmospheric conditions warrant the issue of same.
- h. Increases in wind velocity, or change in other conditions, will be cause for the immediate extinguishments of fires by all permit holders.
 - i. A fine of \$500.00 is applicable by Mass. Law for any illegal burning
 - j. The Scituate Fire Department will immediately revoke the permit if the above rules and regulations are not strictly adhered to. There will be no refund of fees if the permit is revoked for cause.

Beautification Commission Approval for Shed @ Town Hall, Sytske Humphrey, Chair

The Beautification Commission has materials that are currently being stored in various members' garages, sheds, and attics and would like to centralize their equipment. They voted to spend \$6,000 to purchase a shed. The Vo Tech has provided a quote of \$7,000 and there would be a lottery in January of 2025 with no guarantee of being chosen. The Commission also explored commercial sheds and received a quote for a 10x10 shed for \$5,300 plus delivery. Kevin Kelly, Facilities Director has provided the approval of location behind Town Hall, old Board of Health Office. Set up and delivery costs are \$350. There may be an additional fee to add a platform and stones. The money is in the Beautification budget and gift account.

Move that the Select Board approve the purchase of a shed to be installed behind the old Board of Health office located in the rear of Town Hall. Motion by Ms. Connolly second by Ms. Canfield Unanimous Vote (5-0)

Allocate Toll Brothers Funds for Water & Sewer Studies; Regional MWRA Water Study, Jim Boudreau, Town Administrator

As part of the Seaside at Scituate project, Toll Bros donated \$200,000 to be used at the discretion of the Select Board for the following purposes.

- 2) Toll Brothers hereby grants, and the Town hereby accepts, pursuant to General Law Chapter 44, Section 53A, the sum of Two Hundred Thousand and no/100 (\$200,000.00) Dollars for uses to be determined by the Board of Selectmen consistent with said statute (hereinafter the "Granted Funds"). The Granted Funds may be re-allocated by the Board of Selectmen and used for water and/or wastewater capacity studies, bathrooms at Egypt Beach, and/or any other related improvements in the Town, or as otherwise solely determined by the Scituate Board of Selectmen. Toll Brothers shall pay \$200,000.00 of the Granted Funds to the Town on or before September 30, 2018.

To date, \$64,000 has been used for a water study with Tighe & Bond. There is a regional water study proposed for five communities on the South Shore relevant to water supply access through the MWRA. Scituate's portion would be approximately \$8,000.

Move to allocate \$8,000 from the Toll Bros funds for water and sewer studies for the regional MWRA water supply study. Motion by Mr. Goodrich second by Ms. Connolly Unanimous Vote (5-0)

PRESENTATION/UPDATE Scituate High School Tennis Courts Project, Mark Novak, Activitas and Jamie Gilmore, CPC Project Applicant

Mr. Novak provided an update on the project for the High School Tennis Courts. He said this will be on the Town Meeting Warrant under CPC projects for approval. A community meeting was held at the town library. There were some good questions that came out of it but it was not well attended. Thursday of this week there will be a final design meeting then they will go to the Planning Board for a stormwater review. The this will be voted at Town meeting. The project was approved **\$1.957M** and the estimate came in at \$2.2M it is about \$300K over the estimate. When the study was done they used GIS and not a true topographical study. The material export has doubled, the price of concrete has increased and the existing electrical panel there is not large enough to light the tennis courts and storm water solutions. Additional funding is required. Four alternates will be provided with the bid. They may go back to CPC for additional funding at Special Town Meeting in the Fall. They will not know the exact costs until the bids come in for the project. Site challenges

are the existing slopes and will require retaining walls, proximity of the tennis courts and elevations wedged between track and skate park/rink and road, cut to fill operations and construction logistics. The Select Board asked that the storage unity be evaluated. If construction begins in July substantial completion is estimated for October.

Scituate Beach Commission Bike Rack Proposal \$14,784.40, Chris Mason, Beach Commission

The Beach Commission met with DPW and Recreation. The bicycle racks will be powder colored in blue. Bike racks will be at Egypt, Minot, Peggotty and Humarock. They weigh 212 lbs. each. The Board suggested the Beach commission meet with the North Scituate Beach Association. Mr. Boudreau will take a look at the Sand Hills parking area for a potential Bike Rack. This will be a Community Preservation project in May. The beach revolving fund would not require Town Meeting vote but will require a state contract through procurement. Next steps would be to meet with DPW and Recreation Director for funding from the beach revolving fund. Consider purchasing some this year and some next year. Ms. Harrison will send a note to Ms. Holt, Mr. Cafferty and Mr. Lombardo to arrange a meeting for funding, etc. with Mr. Mason.

Amend Annual Town Election Debt Exclusion Ballot Question for Cushing Hatherly School Project

The ballot question for the Cushing Hatherly Elementary School debt exclusion was voted by the Select Board at their 2/13/24 meeting. The question was approved by the MSBA for form but they requested Bond Counsel to also review the article, motion and ballot question. On 3/11/24, Bond Counsel requested a minor addition in language to the article, motion and ballot question.

Move to amend the February 13, 2024 vote to approve the Cushing Hatherly Elementary School debt exclusion ballot question to include the addition of the phrase “including the payment of all costs incidental or related thereto” at the end of the question per Bond Counsel’s request made on March 11, 2024.
