Mr. Antoniello asked if the Committee had full membership. Mr. Heineman explained he had reached out the Moderator to replace Mr. Sandham who had opted not to seek a renewal of his term after many years of service on the Committee and to re-appoint Mr. Westort.

Mr. Kelly inquired as to timing of a fall town meeting. Mr. Boudreau responded that it would likely be between mid-October to mid-November if needed.

Mr. Heineman requested to start the FY 2020 budget review earlier than in past years. Mr. Boudreau noted that the state budget would be delayed due to the gubernatorial election.
