I. Call to Order

II. Approval of Minutes

III. STANDING REPORTS:

Ship Shape Day -D. Bangert provided an update:

2. New adopt-a-lots:

Maritime center, Olympic Park (with support from M. Monse), Humarock. Cost and feasibility for potential library A-a-L will be reviewed by Steve Leach.

Existing tax lot needs repair and requires mulching.

Motion: S. Humphrey made a motion to spend up to \$3000 for library and tax lot. Seconded by M. Tennaro. All were in favor.

IT/Website Manager – S. Casey reported that everything is up to date and has designed several posters for SSD.

Merchant Coordinator – L. Powers the vouchers are ready and there are enough volunteers to distribute them.

Plant Scituate – S. Humphrey mentioned that everything is ready, L. Dienel suggests to acquire two new planters for the Town Hall. *Motion:* S. Humphrey made a motion to approve \$500 to purchase plants and planters. Seconded by K. McCormack. All were in favor.

A suggestion was made to place a blue spruce on the Common. *Motion*- M.Tennaro made a motion to spend up to \$1000 for the purchase of a spruce tree. Seconded by K McCormack. All were in favor.
