 - b. Article 28 Petition Amend Zoning Map to Extend Humarock Village Residential Overlay Zoning District

Mr. Danehey also believes this it to be 'spot zoning' and if it went through the appropriate process that question could be definitely determined.  - c. The Board was notified that Article 30 was amended to add 1 year by the petitioner. No vote was needed.
- 2. Harbormaster Contract, Marina Power & Lighting Pedestals \$112,750 The Harbormaster asked that this be added to the agenda tonight so they can begin ordering the equipment right away.

Move that the Board of Selectmen award the contract for providing 76 Power and Lighting Pedestals for the 2 Town Marina to B & B, Electrical Inc. of 2840 Orchard Lake Road #203 Keego Harbor, MI 48320 for up to \$112,750.00 contingent upon approval of Town Meeting.
