Representative James Cantwell was invited to the meeting to discuss the Governor's Bill on Regionalization of Housing Authorities. He provided Board members and residents with a written summary of the Governor's proposal and of MassNAHRO's proposal. Representative Cantwell informed members and residents that once a Bill is filed it is assigned to committee. A hearing will take place in May or June at the State House. He encouraged residents to write out their opinion of Regionalization and submit it to their legislators. He explained that the Governor is looking for ways to be more efficient and save money. Chairperson, Patricia Butler asked how long the legislative process takes. Representative Cantwell said that a vote would probably be in the next calendar year (July or next spring). He did want to assure residents that "no one will lose their housing". The possibility of holding a coffee hour at each of the community rooms was mentioned to reach out to residents that were unable to attend tonight's meeting. This ended the discussion on regionalization. Chairperson Patricia Butler offered to draft a letter to Tenants explaining the proposal for regionalization.

In addition it will provide information on how an Affordable Housing Coordinator could work together with each of the two Boards mentioned. Generators-Members were advised that the 2011 Capital Fund Grant for Program 49 (Federal) will be used to replace the existing generator at Central Park. In the 400-1 Program (State) \$16,000 was budgeted to complete installation of two Generators, one for the Community Room at Lincoln Park and one for the Community Room at Wheeler Park II.
