Building Project Update

- a. The wrap-up party on June 6th was well attended and enjoyed my many Library patrons.
- b. The Public Building Committee opted to use a furniture company with interior design experience in lieu of an architect charging additional fees. The Town Administrator will develop a group of community members to help in this process.
- c. OPM is working on bid openings
- d. Relocation and Temporary Space: The move was amazingly successful and the feedback of patrons has been very positive. There are still logistical challenges involving air conditioning, computer access and wiring. It is the staff that is being affected more than the public and experts are being contacted to resolve these issues.
 - While the move to the temporary space involved shelving and accounting for a part of the collection, as the remaining materials went to storage; there is some concern that the move "back" to the new space may need more than a week to merge the two collections. Thus there is a request to keep the Library closed for a longer period to prepare for a grand (re)opening.
- e. Incident Reports: A confused patron accidently drove toward the front door and down the sidewalk of 85 Branch Street a few days prior to the June 8th close. Fortunately, no one was injured and the Scituate Police were contacted.
