# Scituate Harbor Advisory Redevelopment Commission (SHARC - Pier 44) March 30, 2023 Minutes

#### Update from Copley Wolff Design Group on March 7 public meeting

Christine Wilson introduced the Copley Wolff Design Team, and presented a slide deck that summarized the two March 7 public meetings on Pier 44 park concepts and related issues. - Issues discussed included viewsheds, a desire for kayak tie-ups, orientation of park space, shade structure, parking alternatives, vegetated buffers, rest rooms, how the park will be used, grading, flood resiliency and funding.

#### **Permitting and Grant Funding**

Christine Wilson and Corey Miles reported on meetings with the Massachusetts DEP and Coastal Zone Management on design, permitting and grant funding for flood resiliency features. They also summarized the ongoing Phase 1 and 2 work, and the work to be performed under Phase 3, as well as additional grant funding opportunities.

#### Public Outreach and Preparation for April 10 Town Meeting

Corey Miles and Paul Bartkiewicz reported on additional public outreach. Many community organizations have sent letters to the Select Board expressing support for CPC funding for Phase 3 work for the Pier 44 park.

Corey Miles reviewed preparation for the April Town Meeting on CPC funding for Phase 3 work.

There was extensive discussion, questions and comments from the Commissioners and members of the public on all of these topics.
