NOTICE TO BIDDERS - INVITATION TO BID

Sealed Bids for the General Contract for 138 Edward Foster Road Seawall Rehabilitation Project will be received by the Office of the Town Administrator, Town Hall, 600 Chief Justice Cushing Way, Scituate, MA, until **9:30 am, EST Thursday June 18, 2015** and at that time and place will be publicly opened and read aloud.

The project generally consists of furnishing all labor, materials, equipment, and incidentals to the seawall reconstruction. This work shall consist of, Dig Safe notifications, verification of benchmark elevations, investigation of existing residence structures in proximity of work and temporary cofferdam/shoring to protect existing residences, protecting, removing and replacing decks and stairs as needed, construction of access ramps, removal of existing seawall, handling ocean tides and waves, surface runoff and groundwater, and excavation to limits shown on plans for the construction of the seawall footing, construction of the seawall and access way including all forms, rebar, concrete, labor, machinery, and materials. Also included in this scope are the installation of, filter stone, weep holes, splash pad stones, and backfill, including all labor machinery, and materials for the proposed project located along Edward Foster Road, Scituate, MA.

Contract Documents may be examined between the hours of 8:30 A.M. and 4:30 P.M. on Monday, Wednesday and Thursday; 8:30 A.M. to 7:30 P.M. on Tuesday; and 8:30 A.M. to 11:45 A.M. on Friday at the Department of Public Works, Administration/ Engineering Office, Town Hall, 600 Chief Justice Cushing Highway, Scituate, Massachusetts 02066.

A pre-bid conference will be held on **June 11, 2015, 10:00 am** at the Selectmen's Meeting Room, Town Hall, 600 Chief Justice Cushing Highway, Scituate, MA 02066.

Contract Documents may be obtained at the office of the Director of Public Works, Town Hall, 600 Chief Justice Cushing Way, Scituate, Massachusetts, during normal business hours beginning on **June 3, 2015**.

A non-refundable deposit of \$50.00 in cash or check payable to the Town of Scituate will be required for each set of the Contract Documents.

The Project Engineer's construction cost estimate for the work is \$1,390,000.

Bidders requesting Contract Documents by mail shall include an additional non-refundable check payable to the Town of Scituate, in the amount of \$20.00 per set to cover costs of handling and mailing.

Each General Bid shall be submitted in accordance with the Information for Bidders and must be accompanied by a Bid Security in the amount of 5% of the value of the Bid.
