CONNECT AND RECONNECT TO THE TOWN SANITARY SEWERS
REFERENCE HOUSE LATERALS

1. An application form for residential sewer permit to obtain a building sewer connection permit must be applied for by the homeowner or his representative. There is a \$50.00 fee for the building sewer connection permit. No fee will be charged for any reconnection.
2. All work in regards to the house lateral will be done by a Drain Layer licensed in the Town of Scituate. (see list below)
3. If the building sewer connection will require a grinder pump to convey wastewater to the municipal sewer, the licensed Drain Layer must be certified by the Town to install the pump.
4. No building sewer connection permit will be issued to the Drain Layer without a Dig Safe number for underground utility locations.
5. Upon completion and before back filling, the work must be approved by the Sewer Division, Town of Scituate. This also pertains to any reconnection.
6. Upon completion of the sewer connection, all cesspools or septic tanks must be demolished and/or filled in.
7. If a homeowner or his representative connects or reconnects to the sanitary sewer without the knowledge or the approval of the Sewer Division, the sewer lateral at the town property line will be dug up, cut at this point and capped. The new lateral will be at the homeowner's expense.
8. No person with sump pumps or any other means, shall discharge or use to be discharged any storm water, surface water, ground water, roof runoff, subsurface drainage, cooling water or polluted industrial process waters to any sanitary sewer.
9. *A sump pump inspection will be required during the lateral installation inspection.*
10. A View port will be required on all new gravity sewer connections for the purpose of monitoring the flow coming from your property during excessive precipitation events and high groundwater conditions.
