

TOWN OF SCITUATE 2024 SPECIAL TOWN MEETING MINUTES

APRIL 29, 2024

The Special Town Meeting was convened at the Scituate High School Gym, 606 Chief Justice Cushing Way, on Monday, April 29, 2024 with Moderator James Toomey presiding.

A quorum of "0" registered voters was declared present and the Moderator called the meeting to order at 7:22 P.M.

Attendance was 809.

Moderator, James Toomey began the Annual Town Meeting and led with the Pledge of Allegiance to the flag.

Motion made, seconded and voted in favor to dispense with the formal reading of the warrant. The Return of Service having been examined by the Moderator and found to be in order. Warrant posted on March 28, 2024.
