Other Business

Ms. Holt asked members to ponder whether they wanted to participate in the March 27th joint hearing on the FY24 budget with the Select Board I person or by ZOOM. A final decision will be made at the March 9th meeting but there seemed to be interest in a hybrid model to allow ZOOM participation. Ms. Holt informed members that the Governor's Office released the FY24 preliminary state aid numbers today and she was in the process of scheduling a Financial Forecast Committee meeting which means that final numbers would be available for the March 9th meeting.

Mr. Doherty asked about the source of the percentage increase for the elected official's salary in ATM Article 1 and Ms. Holt responded that it usually follows the increase provided to the collective bargaining units.

The March 2nd tour of South Shore Regional Vocational Technical School was confirmed for members that did not attend the earlier tour. Mr. Gilmore asked for the deadline for Advisory Committee booklet write-ups and it was confirmed as March 10th.
