## Advisory Committee Meeting Minutes Tuesday, May 10, 2022 Zoom Video/Audio Conference – 6:00 pm

## Reserve Fund Transfer

Deputy Chief Donovan stated the microwave link between the water tower in Cohasset and Town Hall has failed causing a communications interruption for North Scituate public safety communications and that part of the Town of Norwell is also affected. The microwave dish on the Town Hall site has failed and it will cost \$20,490 to replace. The South Shore Regional Emergency Communications (SSREC) will pay for 50% of the cost as it affects one of its members (Town of Norwell). Ms. Russo asked for confirmation of the amount which Ms. Holt confirmed at \$10,245.

Mr. Kelly made a motion to approve the reserve fund transfer in the amount of \$10,245 to replace the failed microwave communication equipment which was seconded by Mr. McGuiggin; the Committee voted unanimously in favor (5-0) by roll call vote; Ms. Russoyes, Mr. Kelly-yes, Ms. Ferguson-yes, Mr. McGuiggin-yes and Ms. Seidel-yes.
