SCHEDULED ITEMS:

Hawker Peddler Renewal Zack's Ice Cream Truck

Move to renew the 2020 Hawker Peddler license to Zack's Ice Cream truck, pending Board of Health approval

Motion by Ms. Curran, Second by Ms. Connolly (4-0) Unanimous

New Hawker Peddler, JB's Doggie Delights Ice Cream Truck

The Board reviewed the additional information they requested such as size of truck and times to visit the Dog Park. They were also notified that Board of Health does not need to inspect the truck as it's not for human consumption and she is selling pre-made dog delights. The Board had no further issues and supports the new hawker peddler.

Move to grant JB's Doggie Delights Ice Cream Truck a Hawker Peddler's License seasonally April through October in accordance with Selectmen's Policy, and to park at the Scituate Dog Park on Tuesdays, Fridays, Saturdays, and Sundays for short periods of time between the hours of 3-8 PM.

Water Restrictions

Sean Anderson explained that our usage is up 22% and this is an unprecedented amount of water use. The plant is at or near capacity and we are starting to get yellow water complaints. All neighboring towns are experiencing the same issues and for the first time we have stopped the water for the fish release in the reservoir. We need to go into a total water ban. Ms. Curran asked what the restrictions will mean. Mr. Anderson explained that it will hand watering only, before 9 AM and after 5 PM, no irrigation, no car

washing. Mr. Goodrich asked if we will be offering rain barrels. Mr. Cafferty noted that the North River Watershed has them but the town will not be coordinating. In 2016, The Board of Selectmen voted to give DPW the authority to enact restrictions and at this time we need to be proactive and go into the total ban.

Move to authorize the Water Department to go into a full water ban effective June 27, 2020.

Motion by Ms. Curran, Second by Ms. Connolly (4-0) Unanimous

Introduction of Ian Kelly, Widows Walk Superintendent

Mr. Boudreau introduced Ian Kelly to the Board who arrived during the pandemic and hasn't had a chance to meet everyone yet.

Mr. Vegnani joined the meeting at 8:45 AM.

Mr. Boudreau sent the cedar point bid results to the Board and explained that the engineer found issues with a bid that was incomplete. The bid we are going with is 7.5 Million and will reduce the betterment from \$42,000 to \$25,000. We currently have 80% of the easements.

Move to change the motion on Special Town Meeting Article 4 from 9.7 Million to 7.5 Million.

Motion by Mr. Vegnani, Second by Ms. Curran (5-0) Unanimous

Move to adjourn the meeting at 8:55 AM
