Decision of the Scituate Zoning Board of Appeals ("the Board") on the application of Ms. Julie Johnson, 260 South River Street, Marshfield, MA ("the Applicant") for a Finding under Massachusetts General Law ("MGL") 40A Section 6 and a Special Permit under Scituate Zoning Bylaw ("SZB") 1020.2 to allow the raze and reconstruction of the single-family dwelling located on a pre-existing, nonconforming lot at 315 Central Avenue, Scituate, Massachusetts ("subject property").

A letter dated April 26, 2010 from the owner, Elizabeth Sherman, was received authorizing representation by Julie Johnson of Custom Home Designs.

The application was received, advertised and an initial public hearing was opened on May 20, 2010 with the following members of the Zoning Board of Appeals hearing the application -

DESCRIPTION OF THE PROPERTY: At the time of the application, title to the subject property was in the name of Alton C. Sherman and Elizabeth A. Sherman by way of a quitclaim deed dated April 21, 1964 and Certificate of Title No. 35205 dated April 22, 1964 recorded with the Plymouth County Registry of Deeds..

The subject property is located in the A-3 Residential District. A portion of the site below elevation 11 is within the Town of Scituate Flood Plain and Watershed Protection District. There is a single-family dwelling and summer screen house existing on the property. The Assessor's field card shows that the dwelling on the property was constructed in 1900 with additional work commencing in 1967.

DETERMINATION ON ZONING BYLAW CONFORMITY: The Dimensional Regulations for lots and residential dwellings in the A-3 District are as follows -

- Lot area for a single family dwelling not less than 10,000 square feet of upland;
- Lot frontage on a street or way not less than 100 feet;
- Lot width at the dwelling not less than 100 feet;
- Setback from any street or way not less than 30 feet;
- Side yard setback not less than 8 feet;
- Rear yard depth not less than 20 feet.

The existing lot and buildings do not conform to current zoning requirements with respect to -

• Setback from street – 24.1 feet (River Road)

The Board determined that the subject lot fronts on both River Road and Central Avenue and is therefore subject to two front yard setbacks.

The Board determined that the subject dwelling was in existence prior to the establishment of the Scituate Zoning Bylaw setback requirements in 1956. Therefore, the Board finds that the property enjoys pre-existing, non-conforming status and the protections afforded by MGL 40A Section 6.

The Board determined that a portion of the subject property is within the 50 foot buffer zone of South River.

PROPOSED PROJECT: The Board reviewed the following documents provided by the Applicant –

1. "Site" Plan of Land drawn by John R. Farren, Professional Land Surveyor, 40 Newfield Street, Plymouth, MA 02360 revised 3/23/09 (one sheet)

The Applicant proposes to raze the existing dwelling, while retaining the existing foundation, and replace it with a new single-family dwelling, which shall not to exceed 35 feet in height at the ridgeline. The Applicant also proposes adding a 475.2 sq ft addition and 448 sq ft garage. The location of the addition shall extend the building on the Northerly side by 18.0 feet extending the nonconformity ranging from 24.1 feet to 28 feet from River Road thus increasing the street setback nonconformity.

No one in attendance at the Public Hearing spoke in opposition to the proposal.

Pursuant to Section 1030.2 of the Bylaw, the Board finds that a) the lot is appropriate for a single-family dwelling, b) the reconstructed dwelling should not adversely affect the neighborhood, c) the use will not create any undue nuisance or hazard to vehicles or pedestrians, d) the Town's Board of Health and the Building Commissioner will ensure that appropriate facilities are provided to assure the proper operation of the single-family dwelling, e) the proposed use of dwelling will not have a significant impact on any public or private water supply, and f) the lot is not located within the Water Resource Protection District. In addition, the Board finds that the use reflects the nature and purpose of the use prevailing when the relevant bylaw took effect, that there is no difference in the quality or character, as well as the degree of use, and the proposed use is not different in kind in its effect on the neighborhood.

THEREFORE, the Board unanimously voted to GRANT the Applicants a Special Permit under SZB Section 1020.2 and Section 820 and a Finding under MGL Chapter 40A Section 6 that the proposal to raze building located at 315 Central Avenue, Scituate, Massachusetts and replace it with a new single-family dwelling as presented by the Applicant is not substantially more detrimental or injurious to persons, property or improvements in the vicinity. Accordingly, the Board determined that the Applicants may construct said dwelling provided that it is constructed as proposed at the hearing and it is completed within two years following the razing of the existing building.
