Paul Mirabito from Ross Engineering, representing owners. March storm filled first floor of house with sand. Structural plans filed with NOI. Existing septic, is intact, and will continue to be used. Plan to elevate on piles according to FEMA regulations. House clearly has damage, so going up is good solution. Same number of bedrooms. As long as driven piles, which we can condition. Frank concerned might be enforcement issues with this property, but the office is not aware. If there are no outstanding issues, Frank is OK with issuing orders, but to add that to the orders. Some other properties in that area the town is discussing with them retreating.

6 MacDonald Ter (raise and rebuild), Applicant: RJB Development Corp., Representative: Gregory Morse, Morse Engineering

Gregory Morse, Engineer with Morse Engineering. Representing owner. 12,512 sq ft. upland land area. Previously developed with single family dwelling. Resource area near property is Herring Brook. 200 ft set back runs through part of lot about 1/3 way through lot. NOI depicts new building and new parking lot with landscape around building. All utilities from MacDonald, not near the Herring Brook. Planning Board approved. Soils good for infiltration. 4,841 sq ft already altered. DEP had no comments. Planning board reviewed Stormwater. Project gets some leeway because already developed site. Seems approvable.

Abutter: 22 4 place. Concern about the building so large on lot so small. Worried will be problems with water and drainage in houses nearby. Frank responded that the soil is good for drainage and other houses are upland from project. This project also is upland from lot next to it. This lot is higher than the parking lot where Duval Dance, ice, CP's – water would go that direction. When the train went in, the town created district to provide opportunity in that area. Definitely has changed the flavor of that area. The commission is trying to look at riverfront area in consideration with development. They are removing a fair amount of vegetation, the mitigation suggested does not seem to be permanent vegetation. Greg – there is a planting plan prepared by Kennedy's. This was approved by Planning Board. The easement area is where most of the plantings are going. He will also submit the planting plan to Conservation. We can incorporate reference to planting plan in the orders.
