When last met asked to get more data on drainage on parking lot. Did title search – 1992 issued permits to raze and reconstruct building at higher location on site and storm damage prevention. Drain installed then. Mr. Patterson can talk to what he did installing drain. Existing pipe from wetland to harbor. CofC issued for the orders, which included storm strain and pipe. Steve Hassel went to the site and ID'd catch basins on property. Reviewed what originally happened and background of company that did the work. Hired to fill pot hole that puddled and ended up pacing section because they had "extra". Did not cover any catch basins.

Frank – can we get annual inspection? Yes can request it.

Frank – if this was a case where storm drains had been covered, would be separate issue. Thank you for your work to find out this information and report it to the commission.

Lisa Bertola, 52 Elm St – described project. The number and types of trees would like to take down. Mostly maples.

Sally – Trees are much larger than they were 12 years ago when garden started. Average age of trees being suggested to take down is 60 years. Planning to install new fence – current one is damaged and falling apart. 20 trees, many maples. Trees are either not healthy, dropping branches and damaging fence.

Penny – thick with trees in that area and provide too much shade, more then since garden started. In Spring will be working on fence and handicap parking, so want trees dealt with first, before new fence goes is.

Frank – we have a forester who has provided info for Town Forest, Is it Ok if this information is shared with him for offering guidance on area? Might have suggestions to not grind trees, and leave them to decay on site. Which also allows slower carbon release.

Andy – Maples grow thick and cover, preventing other to grow.

Jean Shildreck – thank you to ConCom for taking request seriously and everyone covering everything. All the work will be done from the garden side. Happy to have forester review and comment on the site. Happy to maintain seedlings going forward.

Christmas Tree Decoration, Driftway Park Tentative Date December 18, 2021 Jen Foley after last meeting and agreement wanted to deter harmful decorations, but did want to provide outlet and reached out to NSRWA. They were excited about it proposed a tree decorating event on Dec 18. They will bring materials needed and have people make own ornaments on tree that is already there. Was concern about the date being December 18, because decorating has already started. They proposed including in the event, taking down any ornaments already put up, that are dangerous to nature. It would be good to get agreement on NSRWA run with event and our communication and notification and this is the plan. If signs are needed, we can make laminated signs in the office.
- e. Eagle Scout project scout requested building work out/fitness structure on trail area. Commission had concern about trail being most appropriate location, vs school or playground. Scout proposed Driftway Park. Showed example of what would like to build. Thought is as long as in open area, won't have problem had like at Ellis, when similar thing built there and was vandalized. Driftway near picnic tables or large field, should have less chance of vandalism. Safety concerns mentioned, but it is less dangerous than pier at Driftway, and less dangerous then things at playground. No one is against, keep in open space.
- f. Continuous requests policy after so many continuous, option for discussion, and re-advertise once have date. Continuing and continuing for many months. Hard to jump into something after so much time. Pushes other things back because holds up agenda for other items. Richard we should draw a line with the process. Richard suggested have a date to start the policy and give every one notice. Agent tonight's agenda is example where almost everything was continued the day of the meeting.
