Social distancing will be maintained and all COVID protocols will be adhered to. We can accommodate the normal Annual Town Meeting attendance and everyone is welcome to attend. The consent agenda is a great way to expedite the routine matters but does not limit anyone's ability to address or discuss issues. Mr. Toomey looks forward to seeing everyone on April 12th. PUBLIC HEARING Annual Town Meeting FY22 Proposed Budget

Mr. Boudreau reviewed the Fiscal Year (FY) 2022 Operating and Capital Budget Overview presentation. Fiscal year runs July 1st to June 30th we are discussing the Fiscal year 2022 budget at Town Meeting. Mr. Boudreau provided a FY2020 recap, Coronavirus Impact, FY2021 Year to Date, Revenue Assumptions, Revenue Sources, Average Tax Bill Based on Average Single Home Value, Local Receipts, Challenges, FY 22 Operating Budget Focal Points, Budgeted Fixed Costs FY21-22, FY22 Budget Highlights, FY 22 Recommended and 5-Year Rolling Capital Plan, Continuing Obligations for FY 22 and Beyond,

LEVEL SERVICES BUDGET was reviewed with the following details:

- •In accordance with existing financial policies, FY 22 operating budget is balanced without using Free Cash
- •New growth projected to increase due to continued development
- •State aid receipts and assessments level-funded to amended FY21 levels
- •Multiple union contracts expired 6/30/20; two expire 06/30/21 and one expires 06/30/22 estimated amounts included in departmental budgets.
- •One new PT (25 hours/week) position created for clerical support to Facilities Department
- •Funding provided for PT (18 hours/week) for position at New Senior Center to provide lunch, etc. at the Center
- Additional 10 hours for custodial/maintenance at Recreation and new Senior Center
- •Operational support for foreshore protection and roads increased to \$200,000 each.

FY 22 Budget Highlights were reviewed with the following detail:

- •Maintains levels services programs and activities
- •Reflects operational and maintenance costs for new facility
- •Continues allocations for road improvements & foreshore protection
- •Supports commitment to water and sewer infrastructure
- Preserves initiatives previously supported with grant funding (Coastal Resources Officer)
- •Pursues grant opportunities to augment taxpayer funds with grants to address needs in all areas

Ms. Canfield opened the meeting up for public questions and answers regarding the proposed budget. There were no questions from those in attendance.

Becky Malamut reviewed the article and the Water Resources Commission is combining all rules into the bylaw. They are adding tiers, increasing fines for violations and require registration for inground irrigation systems. This way everything will be in one place. Mr. Kelly thanked Ms. Malamut and her commission for their work on this. He said they did a great job.

ARTICLE 25. Zoning Bylaw Amendment – North Scituate, Village Center & Neighborhood District (VCN) and VCN Housekeeping

Ms. Joseph provided an overview of the zoning article. Article required a 2/3 vote. Ms. Burbine said these changes have been in the works for at least six years. This makes sure the zoning articles are in place for when and if sewer comes to North Scituate.

ARTICLE 26. Zoning Bylaw Amendment – Signs (Section 710)

Ms. Joseph said our current bylaw is unconstitutional according to recent legal decisions. The bylaw was changed to meet the new laws. The amendment includes easier to use definitions. Mr. Heineman voted 8-1 not in favor of this bylaw change. This will be a point of discussion at town meeting. Ms. Burbine said the Advisory Board needs to understand this change is not perfect but they did hire a consultant to do this and it was vetted by town counsel. There was also a public hearing held on this and no one from Advisory attended the meeting. Mr. Gilmore said the due diligence that was done was incorrect and not appropriate in his opinion.

Mr. Gilmore has invited the Planning Board to come and speak with the Advisory Board. He is looking for a more common-sense approach. Mr. Westort said not everyone on Advisory voted against this and Mr. Gilmore does not speak for everyone. Ms. Canfield said this will be debated at Town Meeting.

ARTICLE 27. Zoning Bylaw Amendment – Fair Housing and Affordability Standards (Section 754) Ms. Joseph provided a brief overview of this article.

ARTICLE 28. Grant of Easement -First Parish Road

Mr. Boudreau said as part of the discussion and a suit that was filed there is a small grant of easement as part of the settlement agreement with 327 First Parish Road. Mr. Westort asked if it goes with the sale of the house. Mr. Boudreau said yes it goes with the house.

ARTICLE 29. Release of Easement - Gardiner Road

Mr. Boudreau said there is a 20-foot-wide drainage easement. The owner of the property wanted some work done and in return he would give the town a grant of easement.

ARTICLE 30. Petition – Water Conservation Mandates and Rebate Program

Stephanie Burke said the petition is to have the town create a program to replace all non-conforming fixtures to EPA water sense standards. Also, a mandate program with dates that every property would have to replace the fixtures by including building upgrades. Ms. Burke plans to speak with the moderator to amend the article on the floor. Mr. Toomey said once an article is on the warrant, the town meeting is the only one that can amend the action. Mr. Vegnani asked if the only component is the rebate portion. Ms. Burke said she plans to keep the municipal buildings mandate.

PUBLIC QUESTION & ANSWER PERIOD

Jennifer Kuhn, 20 Carrie Litchfield Lane, asked if the Capital Planning Committee minutes are online. The last ones posted are from 2018. Mr. Carchia said he does not have a good answer for that. Ms. Canfield said she will look into this. Mr. Carchia said there were no issues with Capital Planning on the Capital Plan and there is nothing outstanding. They were unanimously approved.

Scott Greenbaum, 40 Damon Road, said there are a lot of people putting in automatic sprinkler systems on their hoses and he wonders if this would be a violation. They leave hoses out and every night at 2 a.m. they are watering their lawn. He asked if this would be considered a sprinkler system. Mr. Vegnani said it has to be hand held and cannot be a sprinkler system. Mr. Boudreau said he would take a look at it and see.
