Police Marine Unit Re-Powering Contract \$69,466, Mark Thompson, Chief of Police

Article 30 of the 04/12/2021 annual town meeting authorized \$77,661 for the re-powering of the marine unit. The work was competitively bid and advertised in the Patriot Ledger, on the Town's website and on COMM Buys. One response was received at the May 20th bid opening in the amount of \$69,466.00 from Green Harbor Marina in Green Harbor, MA. The project includes the replacement of the engines with twin 250 HP engines per the scope of work

Municipal Employee Disclosure, Freya Schlegel, Water Resources Commission

Ms. Schlegel reviewed her business interest with the board. Select Board office contacted State Ethics Division to be sure correct form was used; Disclosure by Non-Elected Municipal Employee of Financial interest and determination by appointing authority as required by G. L. c. 268 A, §19. They are food grade plastic barrels.

Ms. Schlegel will be spray painting them and preparing them as rain barrels. Mr. Goodrich said this is the perfect initiative we want people to do. It is good all around. Ms. Connolly asked if Ms. Schlegel had any financial projections. Ms. Schlegel said they will make approximately \$9 an hour. Ms. Schlegel does not expect to make a lot of money on this initiative. She expects to sell approximately 20 barrels. Mr. Vegnani asked if this would have any impact on her position on the Water Resources Commission. Ms. Schlegel said no.

Move that the Select Board, as required by Massachusetts G.
