### MEETING CALLED TO ORDER/ACCEPTANCE OF AGENDA

Ms. Canfield made a motion at 6:30 p.m. to accept the agenda for August 24, 2021 Second by Ms. Canfield Unanimous Vote (3-0)

### REPORT OF THE TOWN ADMINISTRATOR -

Hurricane Henri thankfully messed up. We had prepared as of Friday morning for a more robust storm but the track took it further west. Good exercise for us to gear up and mobilize some resources on short notice.

- 1. Water Main Construction is in the Utility Road is complete. New services in that neighborhood are now being installed and should be completed shortly. Tie in of the new main to First Parish was being done today. Work has commenced on OOB, from Maple Street to the Rotary. OOB will be closed to thru traffic. Local traffic will be allowed. The laying of the mains should be completed in a day or two, then the contractor will commence work on the individual services.
- 2. Total average demand for the past week was 1.449 mgpd down very slightly from the previous week. With the return of warmer weather, the manganese levels in the reservoir continue to rise. We will continue to monitor usage and, when we feel it necessary, move to the next phase of our water ban, which is a prohibition on outside water use.

The reservoir is at +1.5", and tack Factory is at +4.5. Rainfall over the last 5 days was 1.02" inches. A reminder to residents that our annual water restrictions are in effect May 1<sup>st</sup>. Please conserve water, it is our most precious resource.

The equipment to conduct the pilot studies for the new treatment plant to determine the most effective treatment methods for the new plant has arrived and been installed at the water treatment plant property. We are now entering week 3 of the 7-week pilot study.

3. We have had 24 new case totals in the last week since our last update. This is down very slightly from the 26 of the previous weeks. We with a positivity rating over the last 14 days at 2.93. This continues to climb and mirrors closely the state numbers and is ¾ of a percentage lower than that of Plymouth County. The delta variant is here in Scituate and it is impacting our residents. The data shows that if you are unvaccinated, the delta variant will eventually find you. It is more contagious than the Chicken pox. The vaccine works at protecting from getting the virus and significantly reducing your chances of being hospitalized or dying if you do get COVID after being vaccinated. According to the CDC, 97% of recent hospitalizations are among unvaccinated patients and 99% of new deaths are unvaccinated people.

Please get vaccinated. Consult your doctor and see if the shot is right for you. If you have not been vaccinated, there are plenty of opportunities to do so. State wide the positivity rate yesterday for the past 7 days was 2.81, which is up from the 2.65% of two weeks ago.

New guidance is expected shortly from the CDC and federal government on the booster shots for Pfizer and Moderna vaccine recipients. We will pass that along when it becomes finalized.

Please if you have not been vaccinated, consult with your physician and get vaccinated if that is right for you. As we are seeing, vaccinated individuals who get COVID are far less likely to be ill, end up in the hospital or have a fatal case of COVID. If we are going to get this virus finally under control, more people need to get the vaccine, which is expected to get final FDA approval in the next several weeks.

# Mr. Goodrich arrived at the meeting @ 6:40 p.m.

- 4. Work is continuing on paving on First Parish Road and surrounding the common. The road has been milled, and the contractor has put down the base coat and has begun rehabbing the existing sidewalk on First Parish from Country Way to the new Senior Center. In addition, a new crosswalk is being installed at the top of the hill that will be constructed connecting the senior center to Central Park Drive. This will provide direct pedestrian access from Central Park and the library to the Senior Center, recreation and the food pantry. While the sidewalk work is being done, paving has started on Jefferson Lane, Washington Lane, Clifton ave, and Thomas Ave. They have received a leveling base coat and now the contractor will begin raising the catch basins and manholes in preparation of final paving. A word to the wise, I have spoken to Chief Thompson and once the base coat is placed, we will be doing intensive traffic enforcement in that area. New pavement invariably means higher speeds, so we will be monitoring that and doing enforcement when the base and final coats are installed.
- 5. Renovations on the Steverman rink at Scituate High School has commenced. Demolition of the existing rink is completed and the existing base has been removed. The contractor has finished work on compaction of the area in preparation for the new paving being installed. Asphalt is scheduled to be poured starting tomorrow. The asphalt then must sit for 14-21 days before the finished surface can be installed. During the curing time for the asphalt, the contractor will install the dasher boards around perimeter of the rink. This work of installing a new rink is being funded by the CPC and is scheduled to be completed in September.
- 6. Well 17A green sand filter is progressing. The Building is up and work is moving along on the installation of a green sand filter at the well. Green sand filters remove the iron and manganese from the water before it goes out into the system. These two elements are the leading causes of brown water in our system. As we have discussed in the past, there are two parts to removing the brown water from the system. One is to flush the pipes to remove the built-up sediment in the system which we have been doing and the second is to remove the source of the brown water which is the iron and manganese in the water as it comes from the wells. Hence the green sand filter projects at wells 17A and 18B. New permanent power has been brought to the site, a major milestone for the project. Permanent power has been connected to the building and we are waiting for the installation of the meter. We are moving into the testing phase for the equipment, Scheduled completion is Fall of 2021. We are hopeful we will be ready for DEP inspection sometime in February. Re-activation of this well brings approximately 225,000 250,000 gallons a day back into the system.

- 7. Renovations/expansion to the Widow's Walk clubhouse are ongoing. The \$2.5 million project is expected to be completed in the fall. The walls and roof are up on the new building foot print, so you can see what the size of the new building will be. The contractor installed the base coat for the parking lot last week, with the final coat scheduled for the completion of the project in the fall. At the same time, the project to bring waste water from well 18B to the course in under way. The settlement tank and piping from well 18 have been installed. The green sand filter at nearby well 18B needs to be backwashed and cleaned on a regular basis. The water from this operation will be piped to the reservoir at the golf course for irrigation. Approximately 10,000+ gallons per day will be available for the course when well 18B is in operation.
- 8. Work is continuing on the Humarock Fire station. The footings for the station and the bays are in. Construction of the building itself has started. The walls are up and the roof trusses are in place. The apparatus bay walls should arrive on site by Friday and construction. The project is slated to be completed in the fall.
- The lifeguards will be staffing beaches as follows;

   Humarock will end with guards Labor Day, September 6<sup>th</sup>
- 10. The town will be hosting a press conference protesting the proposed closure of the Scituate Coast Guard station for the next fiscal year. Tuesday, 8/31 10:30 am

Ms. Canfield asked if there was much erosion. Mr. Boudreau said there are some reports of erosion at Minot and there is a lot of seaweed. We are not allowed to remove the seaweed unless it is a public health issue. Mr. Boudreau said signs will be in no lifeguards on duty. Ms. Connolly said she attended the emergency management meeting last week and we are lucky that we have the people we have on our emergency management team. Ms. Connolly asked if we have a way to get an emergency alert. Mr. Boudreau said yes, they can sign up online.

# Acceptance of Donation \$10,000, Scituate Youth Lacrosse

Sean O'Brien, President of Scituate Youth Lacrosse attended the meeting to present the donation to the Town of Scituate, 7 Pennycress Road. Mr. O'Brien thanked everyone involved with the new athletic fields, funding, etc. Lacrosse is one of the first official users of the new facility and has received a lot of compliments from the kids, families and competitor teams. Mr. O'Brien thanked the families and board of directors of Scituate Youth Lacrosse for the lacrosse wall and this donation. It can be used by others such as tennis and soccer. They are proud they have committed the sizable donation and request the funds be used for future maintenance of the athletic fields. Ms. Connolly thanked Mr. O'Brien and the Scituate Youth Lacrosse program and parents for the donation. The donation can only be spent for the purpose intended.

Scituate High School Banners, Scott Paine, Athletic Director, Scituate High School

Scott Paine, Athletic Director, Scituate High School reviewed the banner request with the Select Board. The boosters are asking to hang temporary advertising banners on the fencing during football games. This would be displayed 1 hour before until 1 hour after home games. This would be a one-year plan only. Next year, the high school will secure advertising sponsors for the digital scoreboard. This has been approved by the School Committee. This would be available to all levels (JV and Varsity) all athletic programs. The School Committee has to see every advertiser and approve the banners. The money goes to the booster club for the ad. Next year on the scoreboard the money goes to the High School. Ms. Curran asked if the banners are restricted to the specific sport? Mr. Paine said it would be for the individual sport but sponsors could sponsor more than one sport. Mr. Goodrich said the approval will be up to the School Committee and asked if there was any legal liability. Mr. Boudreau said this is done in many communities and should not be a problem. Going forward this has to be a larger conversation about where the funds go. The Town needs to provide maintenance and will need to discuss who the funds will go to in the future. Mr. Paine said it takes a lot more work to maintain these fields and maintenance is important.

The re-designation for the Scituate Harbor Cultural District was approved today. The Harbor Merchants have held an ArtWalk every year. ArtWalk is an annual event that takes place on First Friday in Scituate Harbor with a special emphasis on artists and musicians. Artist demos will be in various merchant shops all weekend and musical performances will be held on Friday at both the gazebo/bandstand as well as in the area located between 111-121 Front St. in between Hibernian Tavern and the Music Store. Painted buoys will be displaced in merchant locations as part of a silent auction. The painted buoy auction will conclude on Sunday at the Inn at Scituate Harbor from 2-4 p.m. For September it is going to be 2<sup>nd</sup> Friday. Road closure was discussed and the police do not believe we need to close the road. Jersey barriers and saw horses will be used to control the crowd. There is a Facebook account for Scituate Harbor Cultural District and people can find the information there. There will be a police detail near the band. Fran McMillen owns and operates the launch service and mooring service in Scituate. He has served on Waterways Commission and the harbor is his passion. He worked the boat show in 1995 to promote Scituate as a destination port. It is the major port between Boston and the canal. A lot has changed and it is getting better all the time. In 2013 there was a study that came out regarding Economic Development. We lost RJ Dwyer who moved to the North Shore. Ms. Canfield met Fran McMillen working on Scituate Loves Local and would be a great asset to the EDC. Mr. McMillen has represented Scituate at the boat shows for 27 years.

Review & Approve Special Town Meeting Warrant Articles, Jim Boudreau, Town Administrator & Nancy Holt, Town Accountant/Finance Director

There are two petition articles and nine departmental sponsored articles for inclusion in the October 26, 2021 special town meeting warrant. The Board is being asked to confirm the articles to be included on the October 26, 2021 special town meeting warrant so the Advisory Committee and Capital Planning Committee can move forward with review of those articles and the Select Board can vote their recommendations on the articles at a future meeting. Mr. Boudreau presented each article to the Select Board for review. Article 3 Transfer to Reserves was reviewed with the establishment of the SPED Reserve Fund voted at a past town meeting. The SPED reserve fund requires a School Committee vote and a Select Board vote. Ms. Holt said the statute dictates how money is spent. The next year the amount would be rolled into the school committee budget. Bill Burkhead, Superintendent of Schools attended the meeting and discussed Article 4 Feasibility Study & Schematic Design for Hatherly Elementary School. One of the options is to just replace Hatherly and the likelihood of combining Cushing and Hatherly is what they anticipate but that decision will come later. The language does not have a not to exceed number on the warrant. There are a number of projects on the capital plan to replace roofs, etc. and Ms. Connolly asked what will we do with those projects. Mr. Boudreau said we will only do health & safety items. We will only do those things that had to be done and not any long-term major projects until we know if we are going forward. The board reviewed with Ms. Holt and Superintendent Burkhead where the funds would come from to pay for the feasibility study. The article will transfer funds from Free Cash and other available articles to fund a feasibility study and schematic design for Hatherly Elementary School. The cost for the study is \$1.1M and will be partially offset with a reimbursement from MSBA. Ms. Canfield suggests adding an update to the Old Landfill Site Assessment to a future agenda. Mr. Boudreau said the citizen petitions article 10 and 11, Ms. Joseph, Town Planner is working on this and will provide a red lined version in the future.

Move that the Select Board include the 11 articles presented in the draft warrant for the October 26, 2021 special town meeting subject to any further corrections and/or edits by Town Counsel and/or the Town Administrator. Motion by Ms. Curran second by Ms. Canfield Unanimous Vote (4-0)

### **OLD BUSINESS:**

• Request for four Sewer Connections 626 Chief Justice Cushing Highway, Paul Mirabito, President, Ross Engineering Company, Inc.

If the decision is to move the sewer line to the property line this would be required to go to DEP since it could be an expansion of the sewer system. If the connection remains on school grounds an easement would be required and a town meeting vote would be necessary. Wil Branton as the Sewer Superintendent cannot

approve this it would be a Sewer Commissioner decision. Ms. Canfield asked what is the trigger that requires it goes to DEP. This does not meet the requirements for open municipal sewer. Ms. Connolly asked if the property has been sold. Mr. Mirabito said yes, the owner is requesting this. Ms. Curran is not inclined to approve this since the owner is trying to jam four homes into this property. Sewer testing has been done there and septic can be done there. Mr. Goodrich was inclined to approve this because he was nervous about the septic failing near our water supply. The hoops we have to jump through with DEP and there are so many things that could go wrong. Mr. Mirabito said as far as the permits he would pursue all the permits so the town does not have to do this. Anyone who has a septic system a certificate of compliance by the board of health. The bottom line of the form says there is no guarantee that the septic system will function property. This is why he feels the sewer connection is a better option for this site. The property is 8 ½ acres. Mr. Mirabito said he has never had a system fail but he has seen systems fail after a year. If sewer is not approved they will move forward with septic. Ms. Connolly is not in support of this and Mr. Vegnani asked her to voice his opinion that he is in favor of this. Ms. Canfield said we have many homes waiting in line to be added to our sewer system.

The Board votes to deny four sewer connections for 626 Chief Justice Cushing Highway motion by Ms. Curran second by Ms. Canfield Motion carries Unanimous Vote (4-0)

### • Auction of Minot Fire Station

Ms. Canfield recused herself from this discussion @ 8:25 p.m.

The board asked to have a minimum base for the bid. The minimum bid is not in our best interest since it drives less bidders. We have had a lot of interest in the property. It is a non-conforming lot and will require zoning board of appeals. This will all be included in the auction. It is zoned residential and you can do something within the footprint of the building.

Ms. Canfield re-joined the meeting at 8:30 p.m.

## • Financial Policies, Nancy Holt, Town Accountant/Finance Director

These financial policies will be reviewed at the rethnb reat but Ms. Holt wanted to provide the updated documents to the Board. Ms. Holt feels an aggressive policy will resolve some of the Advisory Committee's concerns regarding OPEB. The OPEB funding analysis was provided to show each town is doing it differently. There's lots of different ways to go about funding OPEB. The Board asked Ms. Holt to attend the retreat. Ms. Holt will be preparing an updated debt presentation in September to present to the Board.
