MEETING CALLED TO ORDER/ACCEPTANCE OF AGENDA

INTRODUCTION Advisory Board was introduced by Mr. Gilmore, members Lincoln Heineman and Mike Westort were not in attendance this evening.

PUBLIC HEARING Annual Town Meeting FY23 Proposed Budget

Mr. Boudreau prepared a presentation and provided copies to the Select Board and Advisory Board reviewing the proposed FY23 Operating and Capital Budget. The information was reviewed with the Boards. Mr. Boudreau said the Finance & Forecast committee has met several times to review the budget. 2.7% increase in local aid was announced by the Governor. Budget and Revenue is conservative. Personnel changes include a new HVAC position shared with Scituate Public Schools, an IT position, and added hours for the lunch program at the Senior Center. Scituate Police Department will be working through Police Reform to see how this impacts our community. Scituate Fire Department is working hard to maintain our staff levels and training is very important. Mr. Boudreau met with Kyle Boyd to see exactly what they need in Conservation to help with the backload and Planning. Insurance continues to increase and we are looking at alternatives to address this area. Total budget is \$87M and the schools allocation is \$65M out of the total.

REVIEW Special & Annual Town Meeting Warrant Articles

There are five articles in the Special Town Meeting and twenty-eight articles in the Annual Town Meeting. The Moderator will be holding a separate public meeting to discuss the rules of the road and process during Town Meeting. As soon as we know when the meeting will be held we will post it on the Town website calendar and

send out a news notification. The warrant will likely be posted next week on the Town website. Town Counsel has reviewed and returned the warrant to us. We are doing a final review and then we will post the warrants.

PUBLIC QUESTION & ANSWER PERIOD

Mr. McKeever, 151 Driftway, said he and his family are collectively keeping their fingers crossed for the Scituate High School boy's basketball team. Mr. McKeever said he wants to comment on an Advisory Board member that attacked Mr. McKeever's character. He took his attack personally and he expects an apology due to the misinformation relayed to the board about him personally. Mr. McKeever thanked Mr. Kelly for trying to resolve it. He did not have an opportunity to address this. Mitigation concepts that have been discussed has been a lot of talk whether discussion or hearsay. There has not been any concrete correspondence to help mitigate his concerns. There has been nothing in writing. He does appreciate the work done by both boards.

Ms. Connolly thanked the Advisory Board for all the hard work they have done. Mr. Gilmore thanked the Select Board, Town Administrator and Finance Director for all their hard work and who care about the success of the town.
