The Meeting was called to order at 7:01 p.m.

Acceptance of Agenda

Mr. Harris made a motion to accept the agenda for December 6, 2016 Second by Mr. Vegnani, all in favor. Unanimous vote (5-0).

WALK INS

Joan Meschino the new State Representative elect for North Scituate is here and excited to represent North Scituate. She will be officially sworn in on January 4, 2017. Mr. Danehey congratulated Joan on her election. Beach re-nourishment is an important issue for Scituate and other beach communities such as her hometown of Hull. Opioid abuse is another major issue impacting our community that is a priority.

7:05 **REPORT OF THE TOWN** ADMINISTRATOR

1. Recognition of Firefighter of the Year Award Recipients

Captain Brian McGowan, Lt. Eric Norlin, Firefighter Richard Dehn, Firefighter Tom Hernan, and Firefighter Matthew Regan were in attendance at the meeting this evening. Chief Murphy gave an overview of the accomplishments and bravery of the firefighters who provided a rescue and knocked the fire down at Baileys Island Road. The woman was very ill and in a coma for a couple of weeks. She came by the fire station to thank the firefighters when she was feeling better. Chief Murphy gave a presentation to the board for the Firefighter of the Year award. 10% of the recipients were from Scituate. The citations were given out by the governor. Chief Murphy thanked the firefighters for the extraordinary effort. Mr. O'Toole, Mr. Harris, Mr. Danehey, Mr. Vegnani, Ms. Curran thanked each of the firefighters for their service to the Town of Scituate. State Representative Jim Cantwell presented certificates of recognition to each of the firefighters.

2. Water Update

Reservoir is at 58.9% and we will be lifting some of the water bans since we are headed in the right direction. This will come off of the Selectmen's agenda but future resiliency plans will be included in the FY18 budget to prepare for the future.

3. Public Facilities Update

Both buildings are at 70% complete. We are under very stringent deadlines for the dispatch center. Our cutover from the fire station is determined by the E911 board and is slated for March 1, 2017. We are working on combining dispatch functions with three different employee groups.

4. Other Items

On Thursday, December 8, 2016 we have our visit from delegates from Cork County, Ireland. This is for our new sister city relationship with Ireland. We will be having a signing ceremony at 2:00 on Thursday afternoon at the Maritime Center.

Ms. Vinchesi provided the Selectmen with an update on the FEMA maps. We adopted the FEMA maps in October, 2016. We told our residents that the maps were not perfect but we asked the Woods Hole Group to submit the changes to FEMA and that happened on October 29, 2016. FEMA since then has said we could not file letters of map revisions and the maps are still under review. We sent a letter to our federal delegation to assist us with yet another bottleneck that we are experiencing with FEMA. Representative Jim Cantwell said because we were at the forefront of the appeals process. We were told last March to adopt the maps and everyone agreed this was the process to follow. Mr. Cantwell said it may require a trip to DC. Congressman Keating and Lynches offices are working with Representative Cantwell on this issue. We are asking to allow the letter for map revision. We do not want to put anymore requirements onto the towns of Scituate, Duxbury and Marshfield regarding the maps. The majority of issues are with the regional office. They did not convey all of the information regarding the methodology we used. The agreement was written up and we need to hold their feet to the fire. Representative Cantwell said he would report back to the board in the New Year.

Last Thursday there was a symposium held and there were over 150 attendees for South Shore Coastal communities. Some professors and MAPC were in attendance. Scituate can feel very proud of the work that was done here with the Coastal Resiliency study and the Coastal Resource Officer position.

Mr. Cieslak retired from General Motors and he and Mrs. Cieslak have lived in Scituate and volunteered at the Animal Shelter for eleven years. They know Kim Stewart and there are members ending their term and they would like to help in that role. Mrs.

Cieslak said the shelter here in Scituate is exceptional. They would like to help out on the animal control board. Mrs. Robertson has lived here for over 20 years and when she retired from the library in Norwell she started volunteering at the shelter. They attended a meeting to observe. Mr. Harris thanked them for their work at the Animal Shelter. The Selectmen will vote later in the meeting.

Humarock Coastal Resiliency Grant, Nancy Durfee, Coastal Resource Officer Ms. Durfee told the Selectmen the symposium held last week was full and people had to be turned away. For Scituate we are in the implementation phase and that brings us to the grant. This is for a dune and beach nourishment grant for Humarock. Ms. Durfee reviewed the process for the grant. The funding for this work is provided thru a grant from the Department of Coastal Zone Management (\$103,500). The Town committed to a match of 25% consisting of Town employee salaries (In-kind) and cash of the total Coastal Grant project's cost to bring the total project cost to \$138,000.

Move that the Board of Selectmen vote to award the contract for providing Science, Engineering and Prioritization Services for Elevating Roadway Improvements and Dune/Beach Nourishment along North Humarock for Improved Coastal Resiliency to Applied Coastal Research and Engineering of Mashpee, Massachusetts for up to \$137,500.00. Clapp Road Land CPC Application Revision, Patricia Vinchesi, Town Administrator Ms. Vinchesi provided a map to the Board of Selectmen outlining the maps known as Bartlett Fields. The CPC application was for \$25,000 to do design and engineering work. There are wetlands there. Dan Fennelly asked about the three other town owned parcels and if it made sense to add them to the proposal. If the Selectmen approve, Ms. Vinchesi can amend the CPC proposal to add the other town owned parcels. Mr. Danehey said access to the area is going to be paramount. Ms. Vinchesi said looking at the access in and out will be part of the process. Looking at wetlands will be part of the process as well.

Move that the Board of Selectmen amend the existing Clapp Road CPC application to \$40,000 to include three additional town owned parcels. Motion by Mr. Vegnani Second by Mr. Harris Unanimous Vote (5-0)

Mr. Danehey recused himself from the meeting at 7:57 p.m.

Withdrawal Mayflower Municipal Health, Patricia Vinchesi, Town Administrator, Nancy Holt, Finance Director/Town Accountant, Sue Shillue, Cook & Company, Jack Sharry, Consultant

We started meeting with the Insurance Advisory Committee a couple of months ago due to our concerns regarding the current health care provider Mayflower. We have been working independently and with other towns looking at various options. Cook & Company, Sue Shillue, 20161206 bos minutes

our insurance consultant obtained quotes for us. We received a favorable quote from Mass. International Insurance Association (MIIA). We had a 15% increase last year after several years of zero increase and a 1.5% increase in FY16. A lot of that has to do with the way things are handled at Mayflower. We met with the Insurance Advisory Committee and shared our concerns and the quote from MIIA. The MIIA quote does not represent 100% of the options we provide to our employees now. We are meeting with the Public Employee Committee (PEC) to mitigate the changes since MIIA does not have the Harvard Health Care piece. We have had two meetings with the PEC so far. Ms. Vinchesi has been impressed with the level of concern, information, collaboration and civility demonstrated at these meetings with all eleven unions. Ms. Vinchesi is confident that we will reach agreement with the PEC to present to the Selectmen at the December 20, 2016 meeting.

We must notify Mayflower if we intend to withdraw by December 31, 2016. We went into this process being very clear to the employees that we are not changing their healthcare. We have committed to that and have kept our work on that. This is about the management of the entity that is providing our healthcare. Ms. Vinchesi and Ms. Holt feel very strongly they have a fiduciary responsibility to show that the town has solvency, predictability, communication and transparency in the over \$5M the town spends each year on healthcare insurance and our employees. Increases not only fall on the town but on our employees as well. Ms. Vinchesi turned the meeting over to Nancy, Sue and Jack.

Ms. Holt said two members to date have withdrawn from Mayflower, the town of Rockland and Hingham. 16% of the group has now withdrawn and 16% of the Medicare plans. That was two out of the top five subscribers. On the option of the MIIA plan the last five years of ranges each year the board votes and assigns an increase based on the claim experience. The town can control its own plan design as a partner with MIIA. Ms. Holt explained how the MIIA plan works. Ms. Shillue said while you are part of the pool they also look at the towns own claim experience. With Mayflower, Scituate could be subsidizing other town's claims where MIIA combines it all together with all the communities. Ms. Holt said Mayflower did attend some of our IAC meetings. Mayflower fund balance has not policy in place currently. As of the last meeting Mayflower stated, the fund reserve policy was a guideline and that concerns Ms. Holt. Ms. Shillue reviewed the options of the Mayflower plan in comparison to MIIA. Mr. Vegnani asked what the rate increase would be. Ms. Holt and Ms. Shillue provided projections for Mayflower and MIIA. Ms. Vinchesi said MIIA does not choose all the communities that request quotes but they are very interested in Scituate.

Jack Sharry said his company represents eight groups including the Mayflower group. Jack has the greatest respect for Ms. Vinchesi and Ms. Shillue and understands their position. The Mayflower trust fund was brought down from \$30M to \$18M over the past two years. He believes the Mayflower steering committee does need some changes. Ms. Holt and Ms. Vinchesi are acting based on their fiduciary responsibility and he respects that. Mr. Sharry believes it will be about a 15% increase for Mayflower. Mr. Sharry was asked to come up with a plan for benefits and he is recommending eliminating some legacy plans. He is recommending that the legacy plans are dropped and he is not sure if it will pass. Over the past four years they have run \$20M in the red. \$17M is from this group of legacy plans. If they say no, then Mr. Sharry will

recommend that that particular group get a significant rate increase. Mr. Sharry believes the Mayflower group has righted the ship. He will see what happens over the next month. There are so many variables to determine the rates. Mr. Sharry would like the town to stay one more year but he understands the position of Ms. Vinchesi and Ms. Holt. Ms. Vinchesi said this is a day late and a dollar short on the part of Mayflower. Suddenly they may eliminate the legacy plans but the likelihood of that is very low. Ms. Vinchesi said this isn't about claims experience and we still don't know what the rates will be or what the plan to build up the reserve is. We were the third largest plan and we have only one vote. Our \$5M from Scituate tax dollars and our retiree and employee dollars can be better managed and that's why Ms. Vinchesi asks the board to vote tonight.

Ms. Curran thanked Jack Sharry for attending the meeting and the welcomed objectivity. Ms. Curran does not want to miss the opportunity to join MIAA. Mr. Vegnani is concerned about joining a higher risk pool that is seven times larger than we have now. The MIAA historical rate increase FY13 5.4%, FY14 6.2%, FY15 5.4%, FY16 9%, and FY17 8.9% were the increases. We have 47 employees on Harvard Pilgrim and MIIA does not offer this option.

Barry Shea, 14 Orchard Road, Firefighters Union member asked what rate increase is expected to be if we leave Mayflower. 10.4% from MIAA was the expected increase and 14% from Mayflower. Ms. Vinchesi said the IAC was not presented with any numbers but some projections that were given to the PEC committee. Sue Shillue said at the last meeting we discussed with the IAC the potential savings in the first 12 months in the year. Sue used 14% as a projection for Mayflower because the rates are not set yet. Ms. Holt said we mentioned the Mayflower legacy plans are in 76% of the members and putting in a rate increase is voted by the general board. It is highly unlikely they will eliminate the legacy plans or a high rate increase. If they have not done it to date what is the impetus to do it?

Move to recommend that the Town of Scituate withdraw from the Mayflower Municipal Health Care Group effective July 1, 2017 contingent upon reaching agreement with the Public Employee Committee. Motion by Mr. Harris Second by Ms. Curran Unanimous Vote (4-0)

Mr. Danehey returned to the meeting at 8:37 p.m.

Scituate Library Foundation, Les Ball, President, Virginia Ayers, and Don Nelson, Chairman fundraising committee

Mr. Ball presented the Board of Selectmen with a check for \$100,000 toward the Library project. To date the foundation has given the town \$700,000 toward the building project. Mr. Ball said the 1,000 homes campaign is doing very well. There are 14 Scituate Library Foundation members. They have all been working extremely hard on this project and have made significant donations personally. The Scituate Historical Society committed to donate \$50,000 to name the history room. The Hamilton Charitable Foundation has donated \$100,000 and Harold Brown is the oldest living mosser. Joey von Iderstein's family has raised enough money to name the children's room after her. A picture of the donor board was given to the Selectmen to review.

Over 20 businesses have donated and many in kind gifts by over 650 families in town. The donations as of December 2, 2016 are up to \$1.2 million dollars. The foundation gifts are 8-10 a day now. They would like to hold a gala on April 8, 2017 in the new library. There is a request out to Charlie Baker to attend. The Board of Selectmen supports the gala but would like to move the date out to May since we may not have an occupancy permit in time for the April date. There is the punch list to consider also that will need to be addressed. Mr. Vegnani thanked the Library Trustee's for their impressive effort in fundraising for the library project. The entire board thanked the Scituate Library Foundation for all their work on fundraising.

Mr. Vegnani said there was an Open Space and Recreation public meeting held last week and there was a large turnout. This is a good start to gather information. The field committee is working hard to develop an inventory and see where the needs are in the community.

Mr. Danehey was speaking with Ronnie Simon of R&C Farms and the area in Norwell was taken by Hornstra Farms. We should take a look at some of the acreage to see if there is some space for farming.
