Dear Scituate Residents:

Subject: North Scituate Beach Nourishment Project

Commencing in February and concluding in May 2024, the Town will undertake a beach nourishment project on the shoreline in the area near the Gannett Rd./Glades Rd.—access ramp. This beach nourishment project is made possible through grant funding from the Massachusetts Coastal Zone Management Program, emphasizing the collaborative effort between the community and the Massachusetts Office of Coastal Zone Management to address Scituate's coastal challenges.

Project Overview:

The project is designed to mitigate flood risk and improve the ability of the beach to dissipate waves and reduce overtopping of the seawall behind it during coastal storms.

The nourishment material will be delivered to the beach by truck and spread out using heavy machinery. The nourishment material will be sediment that matches the current mix of sediment on the beach, which is mostly sand with some rounded gravel.

The anticipated length of the project is approximately 1,000 feet of beach. An estimated 60,000 cubic yards of nourishment material will be delivered, equivalent to 2,500 truckloads or approximately 60 to 80 trucks daily. This timeframe begins once school starts and concludes at dusk. Route 3A to Henry Turner Bailey Road to Gannet Road will be the designated route for transporting materials.

The Town of Scituate, our contractors and the Scituate Police will provide traffic control measures during the duration of the project.
