1. Water update. Reservoir is +2" last update was at +3".

Rainfall over the last 7 days was .80" measured at the Plant.

Demand for the last week was at 1.132 mgd compared to last week of 1.245 mgd.

Water restrictions have now been lifted as of September 30, 2023.

2. Water Treatment Plant Project

For the second time, this will go before the Planning Board for review on Thursday October 26, 2023 at 6:30 PM. The design is about 60% complete.

- 3. There will be an update on the Stockbridge Landfill at a meeting this Thursday, October 5<sup>th</sup> at 6 PM at the Library.
- 4. Paving will occur on Front St. the week of October 16<sup>th</sup>. Grinding will begin on October 16<sup>th</sup>, and paving on the 17<sup>th</sup>. Final pave will be done within a few days. Please bear with us during this construction.
- 5. Monday, October 9<sup>th</sup> is a holiday and the Transfer Station will be closed.
- 6. Rt. 3A construction work is on- going. We will be making improvements to the roadway. They will be going back to do services and then they will prep for the final patching phase.
