### **APRIL 10, 2023**

The Annual & Special Town Meeting was convened at the Scituate High School Gym, 606 Chief Justice Cushing Way, on Monday, April 10, 2023 with Moderator James Toomey presiding.

A quorum of "0" registered voters was declared present and the Moderator called the meeting to order at 7:00 P.M.

Attendance was 184.

Moderator, James Toomey began the Annual Town Meeting and led with the Pledge of Allegiance to the flag.
